New Business

Presidents Report Darryl Fowler:

Attended the Hockey Winnipeg Rules and Regulations meetings as well as the budget meeting

Highlights of the rules and regs meeting

- A3 at 13 years old and up is non body checking
- Minor Midget is back

At the budget meeting the only significant things that effected the overall costs were increases for ice and Hockey Manitoba put in an increase in their fees

Met with FGNHA president Mike Wake along with Bruce and Warren about getting the direct entry male program to have joint tryouts and team formation, although the discussion seemed positive FGN wants it to remain status quo. That is not an option for us so will discuss with St Vital about Peewee and minor midget age groups.

Storm jerseys are ordered for the Female program through Royal Sports, Carberry to get apparel sale.

Hockey Winnipeg meeting Sept 8th

There was a Bauer presentation to the board, we asked for more information before making and commitments.

New Winnipeg male sports schools and the effect they have on minor hockey were discussed.

- Discussion on Hockey Winnipeg surplus funds. \$100,000 per year is being distributed to MHA's each year, \$5600 to SWHA in 2015/16 for development.

VP Ice and Scheduling Murray Harding:

- October 24th weekend for A1 teams to start
- House league the following week
- Ft Garry does not have cross ice bumpers, is discussing cross ice rules with Hockey Winnipeg.

Twins Report Trevor Buchberger:

- Twins tryouts start Sept 16, 2015
- Discussion about starting AA at atom level
- 50/50 draws require a lottery license for each date, therefore Twins won't be able to hold 50/50 draws this year.
- Discussion on the date for the AA all star game, last Sunday in January preferred to work around other tournament dates.

VP Direct Entry Warren Hruska:

- Discussed considerations of a merger with other associations
- Discussed 13-17 registration numbers
- Discussed buying socks bulk; decision not at this time

Equipment Ken Whapam:

- Discussed the need to inventory jerseys and equipment for insurance purposes, Ken to complete

Director Player Development Steve Mason:
